## 5 Flexi-Schooling and Alternative Provision

The Chair welcomed John Vass-de-Zomba and Chloe Metcalf to the meeting. The parents of children currently receiving the flexi-schooling provision had requested that they should be allowed to attend the Governing Body meeting to put their case for the provision to continue in its current format. The Chair had agreed to the attendance of two parents to briefly put their concerns to the Governing Body and for the Governors to raise any questions; no documentation was to be issued to the Governors by the parents. The parents had been informed of this prior to the meeting.

The Chair invited the parents to address the Governors regarding their concerns, and John addressed the Governors stating the following;

There are options available within the DfE Guidance now that B code can no longer be used for Flexi Schooling that perhaps were not considered by the Governing Body. The parents want to put forward options regarding Wood School which would allow the current arrangements to continue. The parents also stated that there were some factual errors in the Governors previous information and from the information provided by the LA. The parents issued to the Governors a single page listing examples of the said factual errors.

The parents would like the Governing Body to consider the current arrangements under Code B; Off-site enrichment educational activity. The children are thriving under the current arrangements. The Chair invited questions from the Governors; Q. So are you saying that the school would have to regulate the quality of this provision which would only be available to a small number of children? There are other Forest School providers available.

Q. How many schools in Manchester provide this provision? Possibly four in Manchester. The concern is that some children here have accessed this for a number of years.

NB: post meeting and following verification from the LA, Sheila Newman confirmed that no other schools in Manchester provide this provision.

Q. What are the top three things your children get from the provision that the school cannot provide?

1. Make friends with large groups of children 2. Experience limited risk exposure to outdoor activities 3. Learning how to manage social activities and conflict resolution.

It was noted by the Governors that those entire things are available here at the school.

Q. Is the Wood School somewhere that can only be accessed Monday to Friday? Wednesday, Thursday and Friday.

Q. Is it child only or parent/child accessed? Child only. Parents can volunteer.

Q. Do only Oswald Road children attend on certain days? A mix.

Isobel advised that she was here to represent the LA, which had taken advice from the DfE on this. To clarify, are the parents proposing a move away from attendance code C of the Flexi schooling guidance which is an agreement between school and home schooling? For the school, any approval needs to be looked at in terms of the outcomes for the children. If the activity was to become an approved off site educational activity, the school would be responsible for the funding as the school cannot insist that parents pay for educational aspects.

To the parents; How do St Margaret's record this?

Via code B. The parents are trying to protect the interests of their children and the impact it may have on the children who have accessed this provision and the value added.

Isobel advised that this was a different proposal than expected; the Governors were expecting a flexi schooling proposal and further guidance may be required for a decision to be made.

The parent advised that this was a value added proposal.

The Governors raised the following points;

- If an enrichment activity, wouldn't the school be offering this to a wider range of children; the Governing Body's concern is that as a limited resource it is only offered to a small group of children.
- Also, shouldn't the school identify a need in order to offer this to individual children.
- The Governing Body understands the benefits but has to consider the opportunities for all children.

The Chair advised the parents that the Governing Body will discuss this after they have left the meeting and will determine what happens next. In due course, the parents will be informed of the Governing Body's decision.

The two parents left the meeting.

The parents now need to consider for the school to take responsibility for the off-site provision and the monitoring of the provision i.e not flexi-schooling.

Isobel advised that it is about equality of access, and the context of the school is changing.

Per the parents this is a value added activity and not a core need for their children. What the parents are looking for now would involve the school funding the provision. If the parents elect to home educate, it would be up to them as to whether Wood School was the option.

The fact that Wood School is Ofsted inspected does not preclude the school from the responsibility of the quality of provision. If the school decided to fund this off-site provision, it would have to go out to tender.

The HT issued the 'Vision for future of Flexi Schooling' document and the following points were highlighted in discussion;

The LA Attendance Dept had advised that in the past the school had been incorrectly using code B for this activity. The correct code of authorised absence' or 'unauthorised absence' will significantly impact on the school's attendance and persistent absence data, and will most likely take the school below the National averages.

Members of the parental group have accused the HT of providing the incorrect information to the Governing Body. The HT has only provided the advice as per the LA. Sheila confirmed this.

Isobel advised that the school cannot use code B for flexi schooling; plus the advice on the code C is confusing as the guidance suggests it can only be used for short periods.

The information provided by the parents is selective in terms of the regulations and does not provide the full picture.

Per Staff Voice January 2015, there is little support for Flexi Schooling; teachers are finding it difficult, the staff do support the proposal for the school to cater for outside learning and targeted support for identified children.

It was noted that none of the teachers have identified that there is a need for a child; therefore not a need but as per the parents an added value.

The conclusion from the Staff Voice is that there needs to be wider access to alternative provision.

# Moving Forward

In the 'Vision for the future of Flexi Schooling', the HT proposed two ways that the school will move forward and develop; briefly;

- 1. Wider access to Forest School type activities. The school to develop capacity to deliver this.
- 2. Via the teachers and pastoral team liaising with the family, children who would benefit from alternative provision will be identified. The focus will be to match provision to need.

Flexi Schooling will be considered on a case by case basis via the educational outcomes and impact. There will need to be in place a clear and robust Flexi Schooling and Alternative Provision Policy.

Isobel advised that the school via the HT has the discretion to agree Flexi Schooling on a case by case basis. Per the legal advice there has to be reasonable grounds to refuse it. e.g impact on educational outcomes..

The preference would be to move away from the current arrangements regarding Flexi Schooling; however per the legal advice this could prompt legal challenge. It was noted that the parents are now not asking for Flexi Schooling.

Per the DfE regulations the school can refuse Flexi Schooling.

The Governors confirmed that they liked the HT's proposals 1 and 2.

Q. In terms of the two proposals; can they be weaved into the SEND Policy? SEND is not the correct vehicle for this; needs to be considered on a case by case basis.

Q. Are we waiting for any other advice?

Isobel; The code B, code C and Flexi Schooling advice will not change (subject to outcome of General Election).

Q. Would any of the current 17 children be identified for alternative provision? Yes; at least one.

Q. What exactly was the parents' proposal?

Wood School would become an approved educational off-site activity for pupils at Oswald Road. In addition, the current 17 children would transition to this model, which would then be opened up to other children.

Isobel advised that the agenda item was regarding Flexi Schooling. The Governors have heard from all parties, therefore the Governing Body can make a decision regarding Flexi Schooling.

The Governing Body's priority has to be the outcomes for all children.

It was agreed that the Governing Body will consider the options i.e from both the HT and the parents. No final decision will be formally approved until a robust Flexi Schooling and Alternative Provision Policy has been reviewed and approved by the Governing Body at the next meeting. The staff will be updated accordingly. For the current children, the agreed phased reduction to one day will go ahead.

## 8 Headteacher Update

The HT presented the Autumn Term QA report, which had been issued to the Governors ahead of the meeting. As the 2014 data had previously been reviewed by the Governors, the focus was on the QA Professional's commentary and judgements of the school.

Issues of note for the Governing Body;

- EYFS provision is judged to be good now; it will need to be consistent and outcomes will need to be at least in line with national for this judgment to be maintained.
- Build on early initiatives to improve communications with all stakeholders within the local community
- Ensure all new staff are fully integrated into school life and contribute positively to improved outcomes for pupils.

Q. Page 2, Asian Pakistani progress; is there also an issue with attendance? The LA Lead on Attendance is to come in to work with the school on the reporting and analysis of attendance data.

Q. Are the guidelines on attendance signed and returned by parents? Yes; this is actively pursued by the school.

Isobel commented that the level of progress is pleasing to see.

Q. Behaviour & Safety; comment regarding link between PA 4.6% and Flexi Schooling? The information was correct at the time, so is therefore factual.

Q. Last year EYFS was a key focus; is it now starting to feel robust? Yes. The TLRs in place have had a positive impact.

A very positive report.

<u>Visioning Work</u> The HT presented the outcome from the Visioning Work. The work has been undertaken with staff via twilight sessions. The following 10 words have been voted for by the staff as being the most important in relation to the pupils at Oswald Road;

- Love of Learning
- Independent
- Aspirational

- Self-confident

- Well rounded

In addition, there has been work with and input from the pupils.

The Vision also extends to specific Visions for the classroom, school and wider community.

The 2013/14 RAISE Online data was reviewed, and it was noted that as the school grows the rate of mobility increases. As a result of the International New Arrivals, EAL across the school is increasing.

The school does not receive additional funding specifically for EAL. The school has an EMA Team, and constantly reviews the provision.

Persistent Absence; this tends to be as a result of unauthorised absence i.e. Pakistani children on extended holidays.

Lots of 'greens' (significantly above National), which reflect the school's previous priorities. There are a small number of 'blues' (significantly below National); these relate to a small number of children in small groups.
