

Have you checked your eligibility for **Pupil Premium?**

Your child could be entitled to free school meals, free trips and one free club per year!

What is Pupil Premium?

The government introduced the 'Pupil Premium Grant' in April 2011 and schools are allocated additional funding into their school budget. The premium provides funding specifically for children from low income families who have registered. The purpose of the grant into schools is to raise achievement and improve outcomes for these children. For each child that claims Pupil Premium the school gets £1,320 of additional funding. It is likely that a number of our parents/carers fail to claim Free School Meals (FSMs) for their children, which is part of the Pupil Premium grant, even though they are entitled to them.

Why should I apply?

As the school will receive additional funding based on the number of children who receive FSMs, I am writing to all parents and carers to ask them to make a claim if they believe that they may be entitled to claim for their children and do not already do so. The children at our school can only benefit if we are able to attract additional funding. Our catering team provides an excellent range of healthy lunch options daily, which your child may be able to access free of charge. In addition to this, your child would be entitled to free school trips and one free club per year.

How is the Pupil Premium fund spent?

We use the Pupil Premium grant in a number of ways, whilst ensuring it is carefully targeted for those eligible children in order to help them achieve their potential both academically and socially. The main ways we spend the money are:

- to fund or part-fund the provision of Teaching Assistant support for individuals, small groups and classes to help children to achieve their academic potential.
- specialist art, music and sport teachers.
- to fund the provision of support for non-academic interventions to help increase selfesteem, develop social skills, improve relationships, confidence etc.
- to subsidise extra-curricular activities, visitors and performers to school, plus musical instrument tuition

How do I know if I am eligible?

If you receive any of the benefits listed below, then please speak to Sarah Nicholls in the school office, who will be able to advise you on how to apply for Free School Meals (Pupil Premium Funding):

- Income support
- Employment and Support Allowance
- Child Tax Credit with an annual income of less than £16,190 without Working Tax Credit (as assessed by HMR&C)
- Income-based Job Seekers Allowance
- Guaranteed Element of State Pension Credit
- Support under Part VI of the Immigration and Asylum Act 1999

How do I apply?

In order to make the process easier, the school has invested in an Online Free School Meal Checker. The system allows for you to check you FSM eligibility online, without having to complete and submit the paper copy of the form.
